SAN DIEGO, Sept. 20, 2017 (GLOBE NEWSWIRE) -- Leading retail investment advisory firm and independent broker/dealer LPL Financial LLC, a wholly owned subsidiary of LPL Financial Holdings Inc. (NASDAQ:LPLA), today released its monthly activity report for August 2017.

Total brokerage and advisory assets served at the end of August were approximately \$551 billion, a 0.3 percent increase compared to the end of July 2017. Total Net New Assets for August were \$1.1 billion. Total client cash sweep balances at the end of August were \$28.3 billion, a 3.7 percent increase compared to July 2017.
